Rome Rotary Meeting of September 6, 2011 notes:

Speaker: Rotary's Bruce Melnick, Chief of Volunteers in Police Service

Bruce gave a brief history of the VIPS, which was started by the Justice Department and assists police and fire departments in the inner district of Rome in crime prevention and emergency response. VIPS provide security at authorized events such as those during Honor America Days, traffic control at events and in emergency situations, residential property checks, business checks, an abandoned building ID program, programs for high risk youth, support for dispatch, and in general assist Rome police and fire in serving our community. There were seven VIPS in service to Rome last year, each providing a minimum of four volunteer hours a week.

To become a member of VIPS, citizen in good standing must be at least 21 years of age and have a clean record. Recruits go through an interview process and a background check. Once that is completed there are several courses required. In addition to the main six part course, this includes traffic control, emergency vehicle operation, and CPR. New VIPS must log 20 hours with supervision before completing the program.

Currently VIPS have two vehicles provided by the city, which are clearly marked "Volunteer" and two bikes. Fuel is supplied by Parks and Recreation. Golf carts have been used for park patrol, which is from Memorial Day to Labor Day. Uniforms are a medium blue in contrast to the dark blue of the Rome Police, and badges also clearly state, "Volunteer." The cost to equip one volunteer is about \$1000, not including the upgrades in technology that are on their "wish list". VIPS are supported by Rome Rotary Canalfest funds.

Bruce reported that as part of the Civilian Emergency Response Team, VIPS have made a significant impact on crime prevention and community safety for Rome.

Rotary Foundation - Major Gifts

TRF - a part of Planned Giving

As a part of our estate planning, Rotarians may want to include The Rotary Foundation in their strategy. A Major Gift is a contribution of \$10,000 or more. There are numerous ways to accomplish, which include:

- Accumulated RF giving of \$10,000 or more.
- IRA Charitable rollovers
- Life income agreements
- Charitable bequests
- Life insurance



Below are brief summaries of each, and we will cover them more extensively over the next few issues of The Credo.

Accumulated RF Giving - As you give over year to TRF, you receive multiple Paul Harris fellowships. Once you have give \$10,000 you are automatically designated as a major giver and will receive the recognition materials.

Life Insurance - A policy on yours, or another's life, naming The Rotary Foundation as a beneficiary.

Will - A codicil to your will leaving \$10,000 or more to the Rotary Foundation.

IRA charitable rollovers - New U.S. legislation has extended the IRA charitable rollover -- a provision that permits individuals age 70½ and older to make tax-free distributions of up to US\$100,000 from an IRA directly to charity. This is effective for tax years 2010 and 2011.

Life income agreements - Make a contribution to The Rotary Foundation and take the advantages of a life income gift and turn appreciated assets into an income for yourself or others. Life income agreements are one way to make a significant charitable contribution during your lifetime while furthering your financial plans and security.

Charitable bequests - Each year, thousands of Rotarians and friends designate a portion of their assets in their estate plans to benefit the Foundation. Bequests made through wills or living trusts play an important role in securing the future of Foundation programs by building the Permanent Fund. These commitments also enable individuals to make gifts that may not have been possible during their lifetimes. *To learn more, you may go direction to the RI website by going to:*

The Samaritan Center

Imagine coming upon a green door on a side street in downtown Syracuse. You see a sign saying "All Welcomed", you walk down the enclosed alley to a basement kitchen and dining room, you smell something good, your mouth starts watering and you see 20 Dewitt Rotarians serving a hot nutritious meal to 250 hungry people. Everyone is working hard, but it doesn't seem like work. The atmosphere is positive and you hear thank you, God bless you, and "wow this is good"! Welcome to the Samaritan Center and you think to yourself what a great way to spend a Saturday!

DeWitt Rotary and the Samaritan Center have had a close working relationship for over 15 years. Along the way there have been many changes which Rotary has directly participated in. When new chairs were needed for the dining area DeWitt Rotary donated them, a washer/dryer was purchased by Rotary to launder the many towels and aprons needed for weekly food service, and Rotarians bought a food warmer to help improve meal preparation.

Initially, only bag lunches were offered a few times a year. Rotary does its part by providing 5 to 7 full meals per year including purchasing the food, making the meal, serving the guests and cleaning up. Usually there are 12-20 Rotarians and family serving anywhere from 150 to 300 guests. A typical meal might be: tossed salad, baked chicken, au gratin potatoes, mixed vegetables, rolls and desert.

What has not changed over the years of working with the Samaritan Center is the respect and dignity with which those meals are offered. The Samaritan Center has created a space of safety and hope where, quite simply, if you are hungry, you are welcome.



DeWitt Rotary is proud to be a resource for those struggling. As Rotarians, we believe in the motto "Service Above Self", that we have a shared responsibility to the world in which all of us live and welcome doing our part to feed the hungry.

Service

All Rotary clubs share a key mission: to serve their community and those in need throughout the world. By participating in club service projects, members learn about their club's involvement in local and international projects and can volunteer their time and talents where they are most needed.

Membership recruitment and retention

To keep clubs strong, every Rotarian must share the responsibility of bringing new people into Rotary. Even new members can bring guests to meetings or invite them to participate in a service project. The value of Rotary speaks for itself, and the best way to engage the interest of potential members is by letting them experience fellowship and service firsthand.

Keeping members interested in Rotary is another responsibility. Good club fellowship, early involvement in service projects, and involvement in club operations are some of the best ways to sustain the club's membership.

The ideal composition of a Rotary club reflects the community's demographics, including professions, gender, age, and ethnicity. Such diversity enriches every aspect of the club's fellowship and service.

Attendance

Attending club meetings allows members to enjoy their club's fellowship, enrich their professional and personal knowledge, and meet other business leaders in their community. Club meeting times vary to accommodate members' family and professional commitments. Some clubs meet at lunchtime, while others meet in the early morning, after work, or in the evening.

Rotary policy requires members to attend at least 50 percent of club meetings in each half of the year. If members miss their own club's meeting, they're encouraged to expand their Rotary horizons by attending make-up meetings at any Rotary club in the world — a practice that guarantees Rotarians a warm welcome in communities around the globe. OLESYA CENTER is the only rehabilitation center in Novosibirsk for the treatment of children with complex diagnoses such as autism, cerebral palsy, Down's syndrome and similar disabilities. OLESYA provides children with medical treatment; physical therapy; speech therapy; psychological evaluation and therapy; vocational and educational training. The goal is to give these children the help they need to be integrated into everyday society.



OLESYA CENTER opened in 1992. Although the Center has a highly trained and dedicated staff, the most pressing problem from day one has been the lack of specialised equipment for the rehabilitation of children with diseases such as cerebral palsy. Center Director Lyudmila Kozhevnikova stated, "State-of-the-art equipment needed to treat cerebral palsy is prohibitively expensive; therefore our doctors have to rely upon self-made devices. Our results are good but imagine

how much more we could do with modern equipment." The Rotary Club of Novosibirsk has been improving this situation.

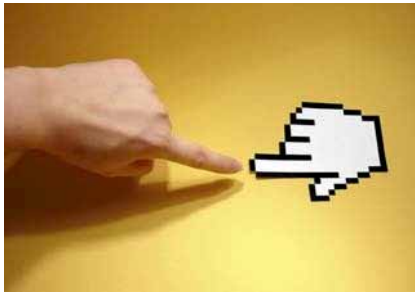

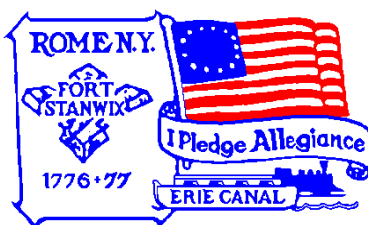
